Several people spoke on support of keeping the ambulance service within the community instead of privatizing because of the service received.

Kathy Bonds-Raines updated the board on the ongoing issue with MMPA spraying the milk on the fields in Middlebury. She stated that she felt that MMPA has not kept up with their testing of the wells.
