OMESA. Some items discussed was the payment schedule of tax revenue, ability to terminate, and liability. Richard Semans, Middlebury Township's OMESA representative recommended not to sign a contract but to continued conducting business as usual. Mr. Bowne stated he felt that times have changed and a contract would protect OMESA and the Township.
