Supervisor Herendeen started a discussion on salary increase. The township board members and representatives have not had an increase since 2002. Mr. Herendeen stated there is never good time to raise salaries but if pay is not adjusted in a timely manner is makes it difficult to raise the amount when times are good and low pay does not encourage qualified people to run or accept board positions. Supervisor Herendeen proposed the salaried position on the township board be raised from \$700.00 to \$750.00 per month (yearly raise from \$8,400.00 to \$9,000.00). He continued to propose the trustee position would be paid \$140.00 per month for the first meeting any additional meeting would be \$40.00 and general meeting fee to \$40.00 from \$25.00. The general meeting fee has been at this rate for 20 years.

Trustee Givens expressed concerned of a raise for the trustee position from\$ 100.00 to \$140.00. He suggested \$ 125 or \$135.
