## Call to Order:

Supervisor Herendeen called the meeting to order at 7:00 pm with pledge allegiance and prayer by Richard Semans.

# **Scheduled Comments:**

She shared with the board the property layout before the motor crossing and what it looks like now. Shelly also shared with the board the taxes that he pays and wants to make sure that he is paying his fair share based on the SEV versus what he purchased the business for. The board stated that the taxes are done by the assessor when she appraises property and it is done appropriately. She stated that one night the race ran after 12:30 and wanted to make sure that he is following the rules and regulations that are set forth. Shelly also shared her concerns regarding the tires that are around the track that is very hazardous to her animals and would like them removed. Supervisor Herendeen stated he could talk with them but the tires are there to stop the racers and for safety reasons not just for the racers but for the neighbors that live around the track. Corky asked if she wanted them to shut down the track and she stated no, she just wanted to share her concerns regarding safety and protection for the neighbors regarding noise, dust, etc.
